

Terms & Conditions for the Swiss Embassy «Julekalender»

DESCRIPTION

1. The organizer and administrator of this promotion is the Embassy of Switzerland in Denmark.
2. There is no entry fee and no purchase necessary to enter the promotion.
3. The overall running time of the promotion begins with the first «Julekalender» post on the 01.12.2018 and ends on the 28.12.2018, 12:00 AM CET. Outside of this time period, no entries to the promotion will be permitted.

PROMOTION DETAILS

4. The promotion has to be entered through [<https://www.facebook.com/EmbassySwitzerlandDenmark/>]. By leaving a comment below one of the twenty-four (24) «Julekalender» post, a participants comment enters the comment pool of potential winners of this day's giveaway. For every day's post, only one comment per person is accepted to enter the pool. Multiple comments from the same person on the same post, will be disregarded.
5. There will be daily posts from the 01.12-24.12.2018. However, the possible time frame leave a comment on these posts and therefore participate in the «Julekalender», is identical with the overall running time of the promotion (see 1.). Entries outside of this period will be disregarded and disqualified. No responsibility can be accepted for entries not received for whatever reason.
6. The Embassy of Switzerland in Denmark reserves the right to moderate the comments and if necessary, deletes entries that violate current laws or Facebook's terms and conditions. These comments are also removed from the daily pool of potential winners.

WINNER SELECTION AND NOTIFICATION

7. Winners of the daily giveaways will be picked at random by software from all eligible entries received by the end of the promotion (28.12.2018, 12:00AM). The Embassy of Switzerland in Denmark administers the promotion, the selection and the notification of the winners.
8. The winners will be notified on the 28.12.2018 through the comment section of the respective «Julekalender» posts on Facebook and additionally, where possible, through direct messaging. Each entrant is responsible for monitoring his/her comment/inbox for prize notification and other communications relating to this promotion.
9. The Embassy of Switzerland in Denmark has no liability for winner's failure to receive notices due to spam or provisions of incorrect or otherwise non-functioning contact information. If the winner cannot be contacted or does not claim the prize within seven (7) days of notification, the potential winner shall forfeit the prize.
